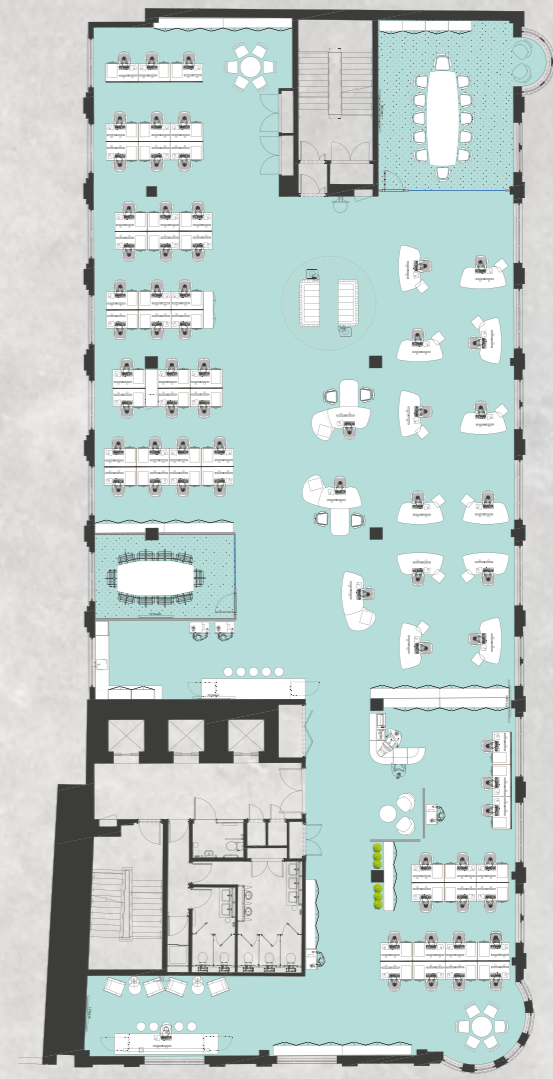

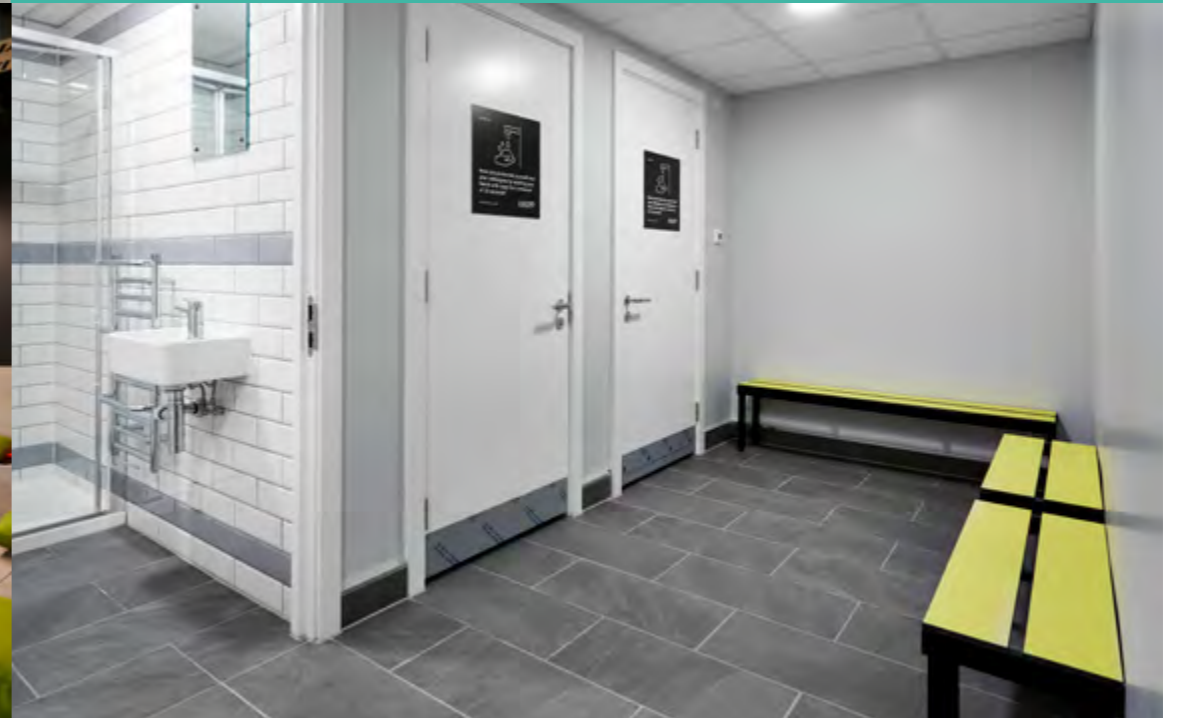
THE SUSTAINABLE ONE

Parking - secure basement car parking spaces are available if required, including electric vehicle charging facilities.

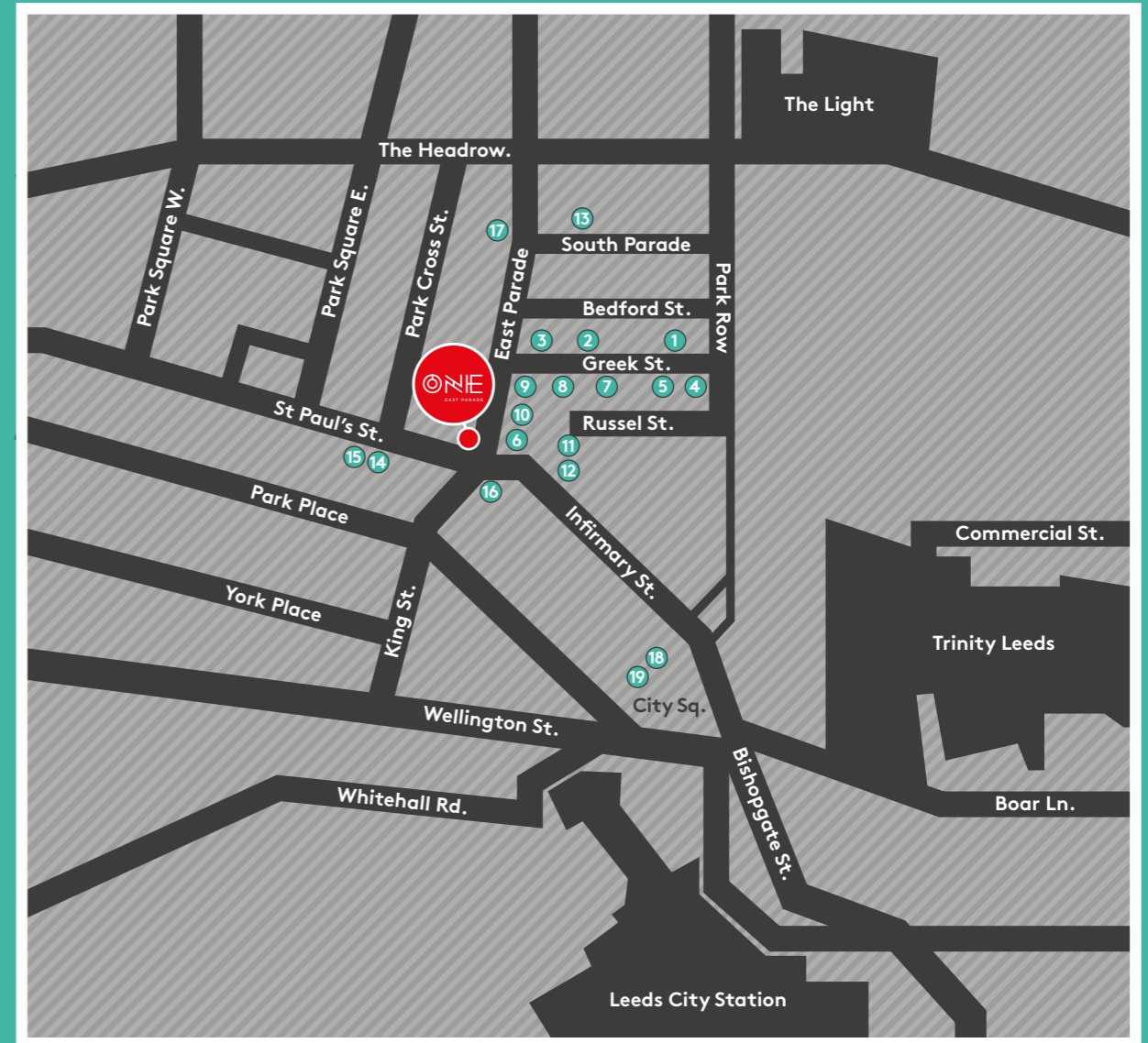
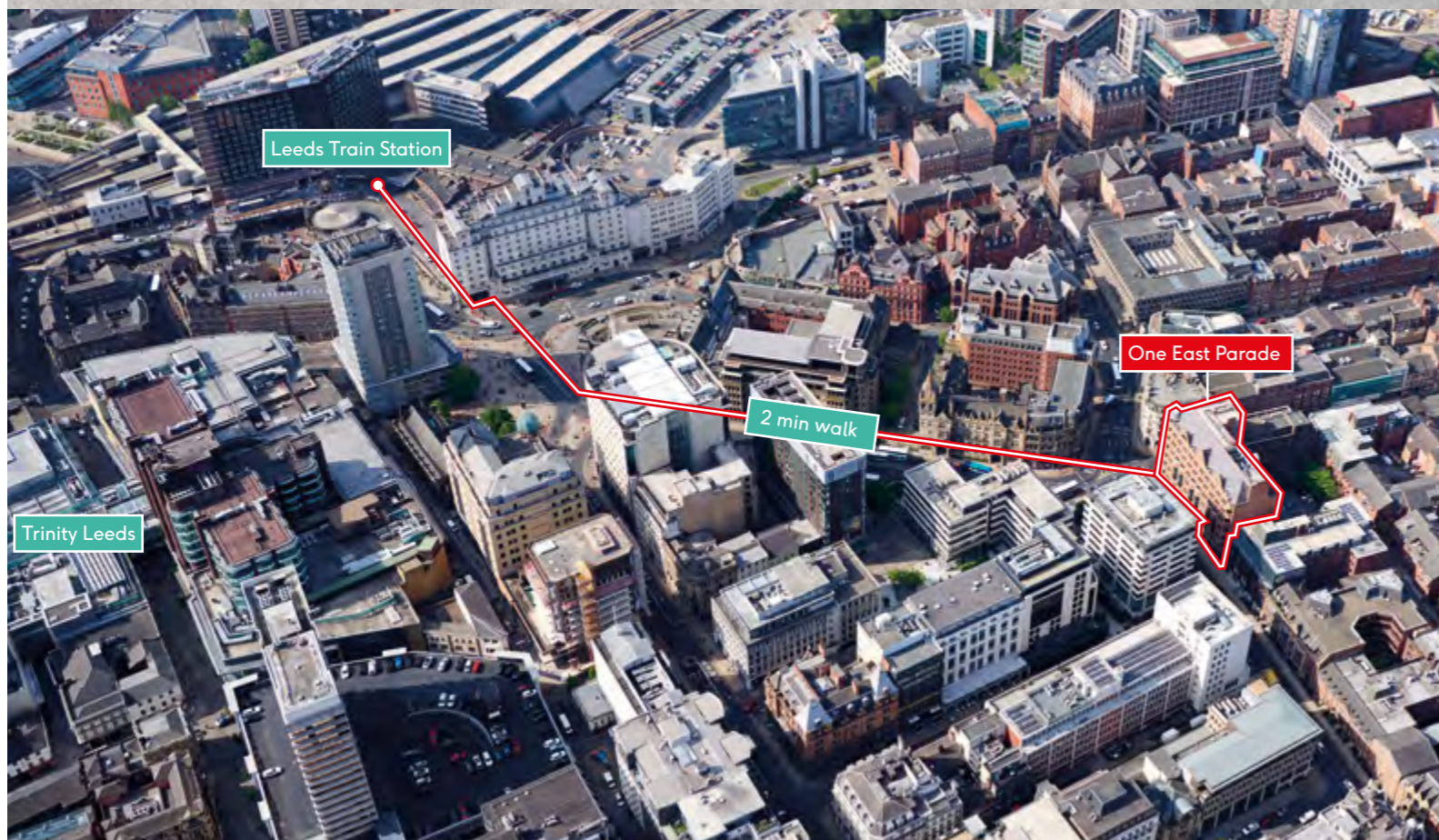
